



Mid-Year Report 2019





In the first six months of 2019, Youth Represent brought comprehensive reentry legal services to all five boroughs of NYC through our community-lawyering model. We:

- Represented youth in 211 cases.
- Taught 53 legal workshops to 846 youth, families, and youth service providers.
- Provided legal representation or advice to 658 youth met at those workshops.
- Obtained 313 rap sheets to help youth understand their criminal records.
- Corrected 34 identified errors. We identified 35 additional errors that we are working to correct.
